LUNG CANCER INITIATIVE (LCI) RESEARCH FELLOW PROGRAM

The LCI Research Fellowship program annually provides five **\$25,000 one-year fellowship grants** for students who wish to pursue a career in lung cancer research, diagnosis, treatment and/or care. Researchers at each of the following institutions are eligible to apply: Duke University, University of North Carolina at Chapel Hill, Wake Forest University, East Carolina University, and Levine Cancer Institute.

- **LCI Research Fellow Program – One-Year Exclusive Naming Opportunity**
 - **One-year naming for Full Research Fellow Program:** \$125,000
 - **One-year naming for Individual Research Fellow Grants:** \$25,000 per grant
- **LCI Research Fellow Program Permanent Naming:** Permanent and exclusive naming for the LCI Research Fellow Program is also possible at a higher level of funding. This can be done through a donation made immediately, over a period of time, or through a Legacy Society planned gift. LCI CAREER DEVELOPMENT RESEARCH GRANT

The LCI Career Development Research Grant in the amount of **\$150,000** is awarded annually to an emerging research leader who is pursuing a career in the field of lung cancer. The researcher's project must be focused on basic scientific research with the goal of impacting lung cancer care, prevention, diagnosis, treatment, or survivorship. Researchers at each of the following institutions are eligible to apply: Duke University, University of North Carolina at Chapel Hill, Wake Forest University, East Carolina University, and Levine Cancer Institute.

- **LCI Career Development Research Grant – Exclusive One-Year Naming:** \$150,000
- **LCI Career Development Research Grant – Shared Naming:** Minimum contribution of \$25,000.
- **LCI Career Development Grant Permanent Naming:** Permanent and exclusive naming for the LCI Career Development Research Grant is also possible at a higher level of funding. This can be done through a donation made immediately, over a period of time, or through a Legacy Society planned gift (see section below).
